

2019 VIREB COMMERCIAL BUILDING AWARDS NOMINATION FORM

ELIGIBILITY

Investment, commercial, or industrial building or renovation projects within the Vancouver Island Real Estate Board (VIREB) area (from the top of the Malahat to the northern tip of the island), and completed between January 1, 2018, and December 31, 2018, are eligible for a Commercial Building Award.

JUDGING

Each submission will be judged on the following criteria:

- Investment, commercial, or industrial building or renovation projects located within the VIREB area.
- Investment, commercial, or industrial building renovation projects completed between January 1, 2018, and December 31, 2018.
- Does it complement the surrounding properties and area?
- Is it aesthetically pleasing?
- Are there unique architectural features?
- What is the level of finish, i.e., choice of construction materials?
- Does it answer a specific development need within the community?
- Does it have any environmentally friendly or green elements for possible consideration?

A panel of independent judges, selected at large by VIREB's Commercial Division, will visit each nominated site, look at the project's overall exterior design, and determine how each fits into the surrounding area. Once all the sites have been visited, the judges will select the winners.

JUDGING CATEGORIES

Awards are presented under various categories. Categories may be adjusted based on nomination responses. Past categories have been as follows:

- mixed-use (commercial/residential);
- seniors housing;
- community - institutional;
- community - recreational;
- retail;
- industrial;
- multi-family;
- hospitality;
- commercial renovation/restoration (both before-and-after photos are required);
- office; and
- green.
