The Vancouver Island Real Estate Board REALTORS CARE® Award

The REALTORS® CARE Awards are among the highest honour the Vancouver Island Real Estate can bestow on its members. They are presented to individuals whose dedication to excellence has had a profound influence on the quality of life in the communities they serve and has had an influence on the professional image on Vancouver Island REALTORS®.

The Vancouver Island Real Estate Board represents 6 geographical zones. REALTORS® CARE Award winners will be identified from these zones by an independent panel of judges.

These awards recognize the REALTORS® personal leadership and service.

Each recipient of the REALTORS Care® award will receive a \$500 donation to the charity of their choice. Please note the charity must be within the Board area.

CRITERIA

All nominations will be reviewed by an independent panel of judges.

- Candidates must be members in good standing of the Vancouver Island Real Estate Board.
- Candidates must have made significant contribution in time and effort with a broad impact to the benefit of the community.
- Candidates' financial contributions to any organization/charity are considered by the judging panel but are not alone sufficient to qualify for the award.
- At least a portion of the candidates' community involvement must have occurred in the two years prior to nomination.
- Testimonials/documentation would be beneficial to the nomination.
- Candidates are only eligible to win the award once.
- Nominations from the previous year are not automatically carried forward but may be resubmitted by the nominator.
- The nominee's signature must be included, showing his/her willingness to stand.
- It is not mandatory that this award be presented every year, but only when the judging panel deems the name of someone truly deserving of this honor is brought forward.
